WAIVER

RELEASE OF LIABILITY AND ASSUMPTION OF RISK

Before proceeding and signing this waiver, I, _______, am able to read and have fully understand the risks associated upon entering the park and the rules and regulations set by PFERP Management Board, including, but not limited to, those identified below:

- I understand that non-compliance, misrepresentation and fraud, merits automatic forfeiture of my visit at any point in time or the visit. No refunds to my deposits shall be made by Paniki Falls Eco-River Park (PFERP)
- 2. That without my valid permit to trek, I cannot enter the park.
- 3. I am aware that my trekking fee includes Guide Service, Welcome Drinks, Lunch Meal (Manobo Cuisine), Souvenir Item and Certificate of Exploration.
- 4. I understand that my party and I must be accompanied by a tour guide at all times inside the trail area.
- 5. I am in good health condition to hike PFERP (should you be pregnant, recovering from surgery, have heart, back/neck/joint problems, or an existing condition that may get aggravated) I will inform the management that I am in full responsibility of my condition.
- 6. I will fill up the Zero Basura Form in declaration of all garbage items I will carry inside the park and carry it again at the entry point for proper disposal.
- 7. I am aware that no alcoholic beverages is allowed inside PFERP
- 8. I understand that guests are responsible and accountable for the group's help, aides and companions.
- 9. I have come in comfortable clothing &closed non-slip athletic footwear (such as trek pants/shorts, trek shoes) appropriate for trail hikes.
- 10. I will bring my own water bottles, preferably able to fit a liter, for the use through the trail.
- 11. I understand that trail visits are a rain or shine activity. However, I understand that cancellations due to severe weather conditions and other concerns may be made by the PFERP Management to ensure safety.
- 12. I understand that there are no lifeguards on duty on the river pools, hence I am held responsible of my own safety as to my child or children.
- 13. I will not litter or create vandals inside the PFERP. I understand that all items brought inside small or large, biodegradable or non-biodegradable must also be brought home.
- 14. I will honor the PFERP's no-smoking policy. I understand that cigarettes, cigar, vapes and alternatives for these are prohibited within the whole area including the parking lot and the roadside/road fronting the fence/gate.
- 15. I will not create noise of any sort and will be conscientious in my movement inside. I understand that these can strain the area's wildlife and disrupt other quests.
- 16. I will not feed nor touch the animals should we be fortunate to encounter wildlife. This may include snakes, leeches, and other forest parasites. Likewise, I understand that picking up of flowers, rocks, and other specimens are prohibited. All of these are here for everyone to appreciate.

- 17. I understand that the weather in PFERP is cold and rainy since it is located in a rain forest. I must be prepared to adjust in the cold conditions.
- 18. I will stay on the trail and not walk beyond the designated steps and areas. I understand that this may harm myself and the flora, as well as affect the trail's cleanliness and safety if not complied with.
- 19. I will ensure that all loose objects such as cameras, sunglasses and other valuable items are secure and will not fall off. I understand that management will not be liable for the retrieval of dropped or loss items.
- 20. I understand that only fifty (50) participants per day are allowed.
- 21. I have known that there are hanging bridges on trailwhich involves exposure to heights.
- 22. I acknowledge the activity may be physically strenuous. I know of no medical reason why I should not participate.
- 23. I understand that PFERP Management Board do not maintain any insurance policy covering circumstance arising from my participation in this activity or any even related to that participation. And such, I am aware that I should review my personal insurance coverage.
- 24. I am fully aware that in case I suffer physical injury or death or incurred damage in the course of trekking, the Local Government Unit of Kidapawan City, Paniki Falls Eco-River Park Management Board including all employees are not liable and responsible from and against any and all liabilities and responsibilities that may be sustained by me or others, in any way arising out of or as a result of my participation in such activity.

I hereby certify that I am at least 18 years of age and am legally competent to sign this release form. If I am under the age of 18, I shall shave a legal parent/guardian sign this agreement, along with myself. I understand that this agreement is between myself (or my parent/guardian) and the PFERP Management Board, and that it cannot be modified or changed in anyway by the representations or statements of any employee or agent of the PFERP, or by me (or my parent/guardian).

That I have read this agreement in its entirety and understand all the terms and conditions it contains and understand that I am giving up substantial rights by signing it, including my right to sue, and sign it voluntarily as my own free act and deed; no oral representations, statements or inducements apart from this agreement have been made. I execute this document for full, adequate and complete consideration fully intending to be bound by the same, now and in the future.
